Introductions: Micah welcomed everyone to the meeting and introductions were completed.

Safety Moment – Paul Schmidt- Paul shared some information on Seasonal Affective Disorder, which is the emotional effects that can be caused by the Fall season. Please be aware of your crews that might be dealing with the related symptoms.

Adopt Previous Board Meeting Minutes: Paul Schmidt moved to accept the September minutes as amended, Alba Vogland seconded. vote record 10-12-22-01

Open Testimony: Jeff Simas brought up a concern that a PUC complaint was made and it took 6 months to get a response and still hasn't heard any follow up. Kevin Hennessey responded with an overview of the complaint response and shared that the PUC is willing to speak to any specific requests. Kevin also shared that the covid pandemic caused some delay in processing complaints.

OUNC Billing & Aging Report: All Board Members have been emailed copies of the billing reports for the current month.

Josh shared that the bulk of the outstanding debts have been paid.

Josh updated the group on the budget.

Kyle asked if we are still set to end the year with a balanced budget, Josh confirmed that we were on track.

Board of Directors Officer's Reports:

Chair's Report: Micah Brown – apologized for missing last month but shared that he had been briefed on the meeting.

Vice Chair Report: Melanie Lewis – Not present

Treasurer Report: Melanie Lewis (Interim) – Not present. Josh shared that the accounting firm doing the audit is doing a deep dive and will be presenting their report at the November meeting.

Secretary Report: Paul Schmidt- Nothing to report

PUC Representative Report: Kevin Hennessey –Kevin updated the board that they are continuing to work with their IT team to build reports that are similar to what the CGA is putting out.

Kevin said that Kitty and Josh have both requested to present on the enforcement process. The PUC and OSHA will be presenting at the December meeting. Scott asked if they would be willing to do the same presentation at the OUCC meeting and Kevin said that they would be happy to if there is a need.

Jessica asked when the board would be able to see the initial draft of the data requested that the PUC is working on. Kevin responded that they should likely see the reportables before the December meeting.

OUNC Staff report: Josh Thomas and Kitty O'Keefe

 - The event is a great opportunity to meet with like-minded groups
 - Learning management systems were a hot topic
 - Positive response was a big topic across the board
 - Kentucky is a new member and had some interesting thoughts
 - Lee shared that she felt like the User's group was a worthwhile meeting
 - Nate shared that there were a lot of great take aways and overall, an amazing event

- Scott shared that Josh did a fine job with his presentation
- Josh shared that the current ORS states that all rules must be consistent with the 1995 OUCC standards manual
- Josh updated the group on the state of the legislative concept process and the items to consider
- PGE training is coming to an end
- Josh sent the team a DRAFT copy of the strategic plan and is requesting some feedback from the board and reviewed the document at a high level.
 - Frank related that trust has been an issue nationwide that the system might be letting down the excavator/operator relationship
 - Kevin shared that he would like to help with the historical timeline in regards to some of the efforts that were happening before the 1997 laws were in place
- Kitty will be starting the 2023 calendar and will have a draft at the November meeting

Committee Reports:

Oregon Administrative Rules (OAR'S) & Tariff: Micah Brown – Micah shared that he feels like the committee hasn't been moving forward as well as he would like, but is hoping to put more energy into it soon. The next meeting will be held immediately after the next board meeting and will address the current issues
