OUNC Billing & Aging Report: The Board has been emailed copies of the billing reports for the current month.

Scott shared an issue OCC has encountered where tickets are not being received by certain members. Scott and Josh met and moving forward, OCC will make an attempt to contact these facility operators twice by phone, email and certified mail as well, they will make an attempt to do a web search for contact information. Once this is complete, Scott will send Josh a list of members that have not been able to be reached and Josh will take this and respond with either a decision to remove the member or to provide a contact solution.

Josh shared a records request OCC received that was resolved by OCC.

Josh shared a concept submission where the members of Mid-Willamette UCC were asking the board to require an address or auto populate an address when a location is submitted that is not connected to a parcel. Josh and Scott will reach out to the MWUCC to attempt to resolve the issue.

Josh brought up 811 assist. Scott shared that there is a company in other states that is trying to start a business where they enter tickets for excavators. 811 assist has been identified as entering potentially "fake" tickets. OCC will continue to monitor the issue.

Josh shared a ticket language change that is being referred to the Policy and Procedures committee.

Kim and Frank shared a presentation that was presented at the September Users Group speaking to why the In and Out ratio has been dropping over the past few years. There are many contributing factors to include improved mapping and technology. This has created a more valuable ticket for operators.

Kevin asked if there was a header and a way to search for reporting unknown facilities. Scott said that there is a unique header called Report Unknown Facility and OCC will get back to him on a search function.

Scott followed up with the group after lunch that these tickets are not their own headers but are processed as emergency tickets with "Unmarked Facility Found" in the type of work field.

Nate Rivera shared that there is a presentation in the board docs around a tariff adjustment.

Josh spoke to the highlights of the summary.

Kevin recommended that the board work with OCC to get reporting on the reported square footage/mileage requested.

Discussion followed as to how the board might validate the exemptions noted in statute.

Jessica Epley moved to hold a hearing at the April OUNC Board Meeting for the .09 cent rate adjustment proposed to be implemented on July 1, 2024, Andy Crocker seconded. vote record 2-15-24-02

Jessica Epley moved to initiate an annual process by which the board will review the Service Tariff Rate on an annual basis for adjustment that is based upon the Consumer Price Index for All Urban Consumers (CPI-U). The Frist annual review of the service tariff rate would occur in July 2024 in preparation for the 2025 budget cycle. This proposal will be referred to the Budget, Audit and Tariff Committee and Policy and Procedures Committee for review. Andy Crocker seconded. vote record 2-15-24-03

Jessica Epley moved to discuss an exemption validation process in the policy and procedures committee, Nate Rivera seconded. vote record 2-15-24-04
