Josh shared with the board the proposed tariff adjustment amounts and justifications.

Jessica Epley moved adjust the per ticket rate from \$1.40 to \$1.49 on July 1, 2024, and change the voice transmitted ticket rate from \$7.58 to \$8.01 on July 1, 2024, Nate Rivera seconded. vote record 3-04-24-05

Melanie asked if OCC could add this messaging to the invoice.

Discussion followed around finding a better understanding of where the board is losing revenue and how they might better understand the factors involved in justifying tariff adjustments.

Melanie suggested that a concept submission form on the issue of a cost analysis be submitted. Nate will put a group together and discuss the issue.

Training and Education Committee: Mitch Burghelea – Mitch shared that the schedule is updated on line.

Josh shared some upcoming excavation training.

Policy and Procedures Committee: Jessica Epley – Jessica shared the committee met with the OAR committee. She followed up by making recommendations to the board.

Jessica Epley moved to accept the recommended addition to the Policy and Procedures manual listed in Issue Summary #23-09-0035b, Jaimie Lemke seconded. vote record 3-04-24-06

Brewster Whitmire moved to allow adjustments to the Policy and Procedures Manual in section 3.8 Unless otherwise decided by the board, the Service Tariff base rate will be revised annually. Beginning each July, the board will consider increasing the rate for the subsequent calendar year by the greater of two and a half percent (2.5%) or the actual percentage of increase in the consumer price index (CPI) up to fine percent (5%). The CPI is found on the Bureau of Labor and Statistics website, listed under All Urban Consumers (CPI-U), and it is the same calculation used for the notification center contract, Matt Barrett seconded. vote record 3-04-24-07

Brewster moved to allow adjustments to the Policy and Procedures Manual to accommodate this addition. Current section 3.8 will become section 3.3.8, and section 3.3 will be renamed Banking. New section 3.8 will be renamed Tariff, Andy Crocker seconded. vote record 3-04-24-08

Brewster Whitmire moved to accept the proposed language for addition to the Policy and Procedures Manual and initiate self-certification process starting in 2025 as mentioned in Issue Summary #24-04-0040, Matt Barrett seconded. vote record 3-04-24-09

Josh shared that the manual has been updated with clothing allowance language.

Josh updated the board on Issue Summary #24-04-0041 around Notification Center RFP. The committee proposed that entire board be involved in work sessions designed to review the contract. Discussion followed. The board agreed to add a contract work session to the agenda moving forward.

Notification Boundaries Committee: Kevin Hennessy- Kevin shared that there haven't been any real updates since the past meeting. Kevin shared that the overall coverage area in Oregon has decreased by 7 square miles.

Kevin suggested that these issues should be considered in the process that is being led by Nate around a cost of service analysis

Data and Research Committee: Lee Tumminello – Josh shared that there will be a meeting scheduled after this meeting. The group will report back later.
