**OUNC Operations Report:** Greg Snyder reported that the Boards request to add two new fields (Work Order # and Permit #) was submitted to OCC Systems.

Greg read the verbiage that was approved to be included in the member's invoices advising of the new 1.5% interest charge on balances 60 days or more past due.

1) Before charges go into effect:

Effective September 1, 2020 all balances over 60 days past due will be subject to an interest charge of 1.5% per month.

2) 9/1/20 invoice and going forward.

Balances 60 days or more past due will be assessed an interest charge of 1.5% per month

All Board Members had previously been emailed copies of the June 2020 operations reports. Greg Snyder went over the highlights for the month. The incoming ticket total for June was 32,354 tickets, which is up 11.16% from June 2019. The ITIC percentage for June was 62.38%, up from June 2019's 61.19%. The Average Speed of Answer (ASA) was 26 seconds for June 2020.

#### **Committee Reports:**

**Budget and Audit Committee:** Johnny Sapp: Johnny reported that a committee meeting was held on 6-10-20 and the meeting minutes will be coming out. They discussed and tabled three items:

- 1) Creating separate budgets for Publicity and Education
- 2) Posting documents to the transparency website
- 3) Adding information in the Policy and Procedures Manual. That is on hold until an Executive Director is hired.

Johnny advised the Board that the Riverview CD is up for renewal on 7-10-20 and went over the available options. After discussion Ryan Sandhu made a motion to renew the CD for 9 months at 0.25%. Jessica Epley seconded the motion. Vote record 7-8-20-04

**Publicity Committee:** Scott Clement – Scott noted that the National Excavator Initiative (NEI) TV campaign, featuring Mike Rowe, will be running August – October 2020. The OUNC Board approved funding for this campaign at last months meeting.

There will be a conference call with the Hillsboro Hops next week to get updates on the 2020 season.

The Starlight Parade has advised the OUNC that there will not be a live parade this year.

Vancouver Dozer Days is scheduled for Sept 26-27 2020.

The OUNC store shipped out 75 orders last month. This is three times the normal volume. The biggest movers were hand sanitizer and the buffs.

**Training and Education Committee:** Mitch Burghelea – Mitch checked with the Locate Training instructor (Bob) and he has online training available. Mitch reported that this year the OUNC has only been able to provide one Locate Training class and the rest of the classes have been put on hold. He would like to move forward with online training. Each online Locate Training Session consists of four classes and costs \$1,800 per session. After discussion Dawn Hickson made a motion to fund two sessions of online Locate Training at \$1,800 per session. Scott Clement seconded the motion. Vote record 7-8-20-05. The contract with the instructor for Locate Training expires at the end of the year 2020. Will need to put out an RFP. Mitch will notify Nate Rivera, Chair of the Contracts Committee.

Mitch reported that the Excavator Safety Training classes with Clint Kalfell are also on hold. However the OUNC online Excavation Safety 101 is available. Kitty O'Keefe noted that 202 people completed the online class so far in 2020.
